GUEST/OPERATOR AGREEMENT

In consideration of being permitted to participate in hunting, trap shooting, Big Sky Sporting clays and sightseeing and accompanying hunters or shooters, or for any other related activities engaged in by Guest, for himself or herself, his or her spouse, or children, and all of those accompanying Guest while attending such activities (hereinafter collectively referred to as Guest), the undersigned Guest hereby releases, waives and discharges Van Voast Farms, the owners and lessees of the premises, including Big Sky Sporting Clays, promoters, sponsors and advertisers, and each of them, their officers and employees (hereinafter collectively referred to as Owner/Operator), from all liability to the Guest for any and all loss or damage, and any claim or damages resulting therefrom on account of injury to Guest's person or property even an injury resulting in death whether caused by the negligence of Guest, or otherwise, while Guest is involved in hunting, trap shooting, shooting sporting clays, sightseeing, accompanying hunters or shooters, or other related activities on the property operated by Van Voast Farms and Big Sky Sporting Clays.

Guest agrees to indemnify Owner/Operator, and each of them, from any loss, liability or cost Owner/Operator may incur due to the presence of Guest in or upon Owner/Operator's property, whether caused by the negligence of Owner/Operator, or otherwise.

Guest represents that he or she is experienced at gun handling, shooting and bird hunting, does not need instruction in these areas, and is fully cognizant of all of the inherent dangers of gun handling, shooting, bird hunting, shooting sporting clays, trap shooting and sightseeing under field conditions.

Guest agrees that hunting or shooting with a firearm, bow or other instrument is an inherently dangerous and hazardous activity and injury may result from gunshot, arrow, malfunction of a gun, weapon or equipment, locomotion, transportation, slipping, falling, shifting of the ground, encountering wild animals, poisonous reptiles, poisonous spiders, noxious insects, misbehavior of dogs, shot fall, lead poisoning, broken or not broken targets, accidental discharge of gun, ear damage, eye damage, damage to gun or weapon.

Guest understands that it is not the purpose of Owner/Operator to teach safety rules, nor is it the function of Owner/Operator to teach safety rules, nor is it the function of Owner/Operator to serve as guardian of my safety.

Guest hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of Owner/Operator, or otherwise, while Guest is hunting, trap shooting, shooting sporting clays or conducting any other related activity. Guest assumes full responsibility and risk of loss or damage for all of his or her equipment and the shells used.

Guest represents that he or she is physically and mentally able to engage in these activities, is of lawful age, competent to sign, maintains his or her own personal injury and personal property and liability insurance in the event that an injury is sustained or loss incurred, and has no physical or mental impairment, or an impairment caused by the use of medicines, drugs or alcohol that can or will endanger self or others.

Guest understands that the "Trail Network" throughout Big Sky Sporting Clays is designed for foot traffic. The use of or riding on motorized vehicles is not recommended and is at operators and riders own risk.

Guest further agrees as follows:

1. To abide by all applicable state, local and federal laws, rules and regulations.
2. To confine his or her hunting, shooting or other activity only to the assigned area.
3. To have a shell or cartridge in the firing chamber of a gun only when engaged in hunting on foot, when waiting for a bird on the firing line at the practice shooting range, in the station at the Sporting Clay facility or on the pad at the trap range.
4. To always carry loaded guns while engaged in hunting, except at time of firing, with the safety in the ON position.
5. To keep guns empty, both chamber and magazine, at all times when not in the field actively engaged in hunting, and to keep the breech open unless the weapon is securely in place in a gun rack.

Violation of these rules, which are intended to provide a safe shooting opportunity for all, shall result in the revocation of the membership without a refund. Guest understands that these terms are contractual and he or she represents that he or she has read this release and fully understands its contents and ramifications. The terms hereof shall serve as a release and assumption of risk for Guest and Guest's heirs, executors, administrators, all members of Guest's family and all minors who shall accompany Guest.
